

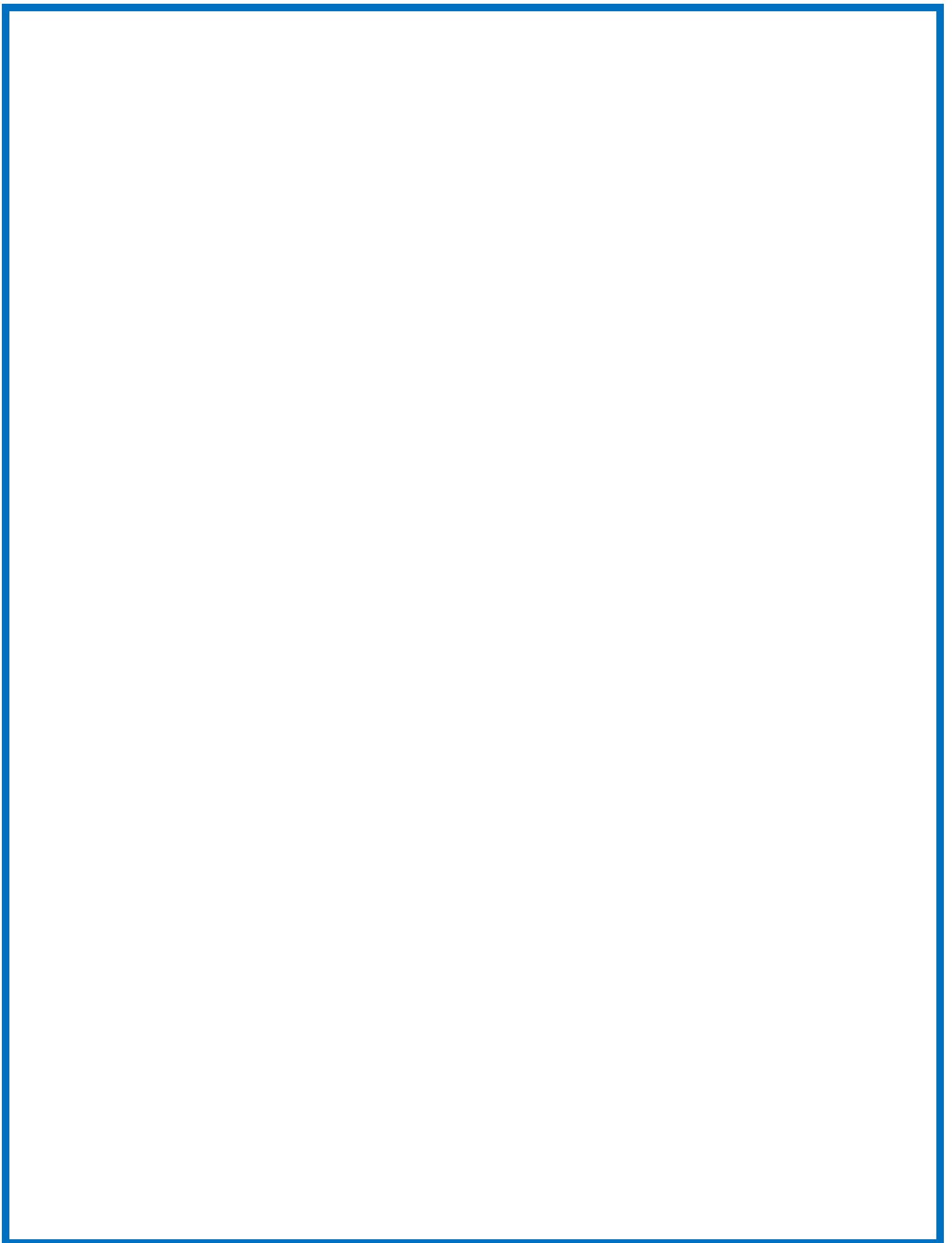

PROGRESS REPORT
PARAMARSH
(An UGC Scheme)

University Grant Commission (UGC), New Delhi Vide Letter F.No.-PARAM-2019-CLG-MAD-1722-253, dated. September 11, 2019 approved RIE, Bhopal as Mentor Institution under the scheme of 'Paramarsh' for mentoring NAAC accreditation aspirant institutions to promote Quality Assurance in Higher Education for a period of one year with an allotted budget of Rs. 30,00,000/-. Six aspirant institutions of Gwalior region were allotted. The initial process began with a meeting held with the aspirant institution where MOU was signed with RIE Bhopal to be the mentee institutions under the scheme. The six mentee institutes were:

1. Govt. Gandhi College, Balaji, Mihona, Bhind, MP
2. Govt. Maharshi Arvind College, Gohad, Bhind, MP
3. Govt. Nehru College, Sabalgarh, Morena, MP
4. Govt. Degree College, Akoda, Bhind, MP
5. Govt. Degree College, Indergarh, Datia, MP
6. Govt. Law College, Datia, MP

Out of the allocated grant of Rs. 30,00,000/- (Thirty Lakhs), the first installment of grant of Rs. 15,00,000/- (Fifteen Lakhs) was released by UGC vide their letter no.F.50-64/2019(IC) dated March 11, 2020, received in May, 2020. Due to the outbreak of corona pandemic, country wide lockdown was imposed and programmes under the Paramarsh scheme could start from the month of August, 2020 with the permission of UGC mail dated June 18, 2020.

The scheme was initiated under the leadership of the Principal, Prof. Nityananda Pradhan, Director of the IQAC Prof. (Lt.) Rashmi Singhai and its Accreditation Ambassador Prof. Anil Kumar along with faculties of the institution. Meticulous planning and team work were the pillar of this project.

OBJECTIVES:

The overall objective of the scheme is to enhance the quality of the Mentor Institutions & mentoring the Non-Accredited Higher Education Institutions to enable them to get accredited. The institution works in close coordination with Madhya Pradesh Higher Education for the successful implementation of the project. The project is being executed by the Internal Quality Assurance Cell (IQAC) of Regional institute of Education, Bhopal. The scheme was initiated under the leadership of the Principal, Prof. Nityananda Pradhan, IQAC Director Prof. (Lt.) Rashmi Singhai and its Accreditation Ambassador Prof. Anil Kumar along with faculties of the institution. Meticulous planning and team work is the pillar of this project.

Indubitably this project will prove to be a platform that facilitates mutual learning for the mentor and mentee institutions and to work in line with the quality mandates set by UGC for quality enhancement of Higher Education Institutes (HEIs).

Activities undertaken

The various activities were undertaken inspite of the pandemic (Corona), in the RIE, Bhopal as Mentor Institute, for the preparation or readiness of the Mentee Institutions under different parameters of NAAC accreditation process leading to preparation of SSR, ultimately contributing to the enhancement of quality in higher education. Looking in to the situation of Covid-19 pandemic, some of these workshops were held on-line, while some others were held offline.

The details of the programme conducted are:

ACADEMIC AUDIT (STATUS STUDY) OF THE MENTEE INSTITUTIONS

The Mentor Institute made an effort to have an academic audit of the Mentee Institutions, as a whole unit of State Education Department of Madhya Pradesh to look in to the strengths and weaknesses of the institutes as a whole on different parameters of NAAC accreditation of quality and then to prepare an action plan to use those strengths to multiply and convert weaknesses in to opportunities to realize the cherished goal of quality. For this a basic questionnaire was developed (Schedule for Obtaining Preliminary Information from Mentee Institutions, **Annex-I**) To study the strengths and weaknesses of Mentee institutions, as a whole, on different dimensions of quality were arrived based on the collected responses from the principal and the faculty of the six Mentee Institutions with the help of an on line survey using a well designed questionnaire developed by Mentor Institute on different quality parameters / criteria of NAAC Accreditation process viz.

1. Curricular Aspects
2. Teaching, Learning and Evaluation
3. Research, Innovations and Extension
4. Infrastructure and Learning Resources
5. Student Support and Progression
6. Governance, Leadership and Management
7. Institutional Values and Best Practices.

Based on data collected through questionnaire, two separate status reports- Institution wise on each parameter (**Annex - II**) and parameter wise for all the institutions (**Annex-III**) together, were prepared to help in proper planning, for the development in each quality parameters/criteria

The questionnaires was sent through e-mail among all the Mentee Institutions and on the receipt of the responses and information to the questionnaire, they were classified as per the requirements, analyzed for their strength and weakness and then prepared the status report of each mentee institutions as per the information received. Each individual institution status report was sent with the remark of strength and weakness and gave an assurance to help the

development in every aspect of the quality parameters/criteria through conduct a NAAC criteria specific programs or workshop by expert resource persons on different area on NAAC related data management for IQAC coordinators and Heads of Mentee institution by IQAC, Curriculum planning, implementation, development of e-content and library resources, activity on research topic, etc. which will help the Mentee Institutions to prepare of SAR documentation for NAAC process. This analysis helped the mentee institution to work on their weakness and utilize their strength for the upliftment of the quality of education and other parameters related to NAAC.

UGC PARAMARSH SCHEME – INITIATION

August 14, 2020

The one day launching programme was held on-line in Google Meet platform on August 14, 2020 under UGC's 'PARAMARSH' scheme. All the members of the Mentee Institutions introduced themselves. Prof.(Lt.) Rashmi Singhai, Director, IQAC welcomed all the members and presented the objectives of this workshop. The Principals and faculty members of the six mentee institutions and Director, NCERT and faculty members of RIE Bhopal attended the webinars.

September 07-08, 2020

Two days workshop on Action Research was held on-line in Google Meet platform on September 07-08, 2020 to facilitate the environment of doing research. Prof. Nityanada Pradhan, Dr. Saurabh Kumar and Dr. Sangeeta Pethiya participated as resource person and members of all the mentee Institutions attended the programme.

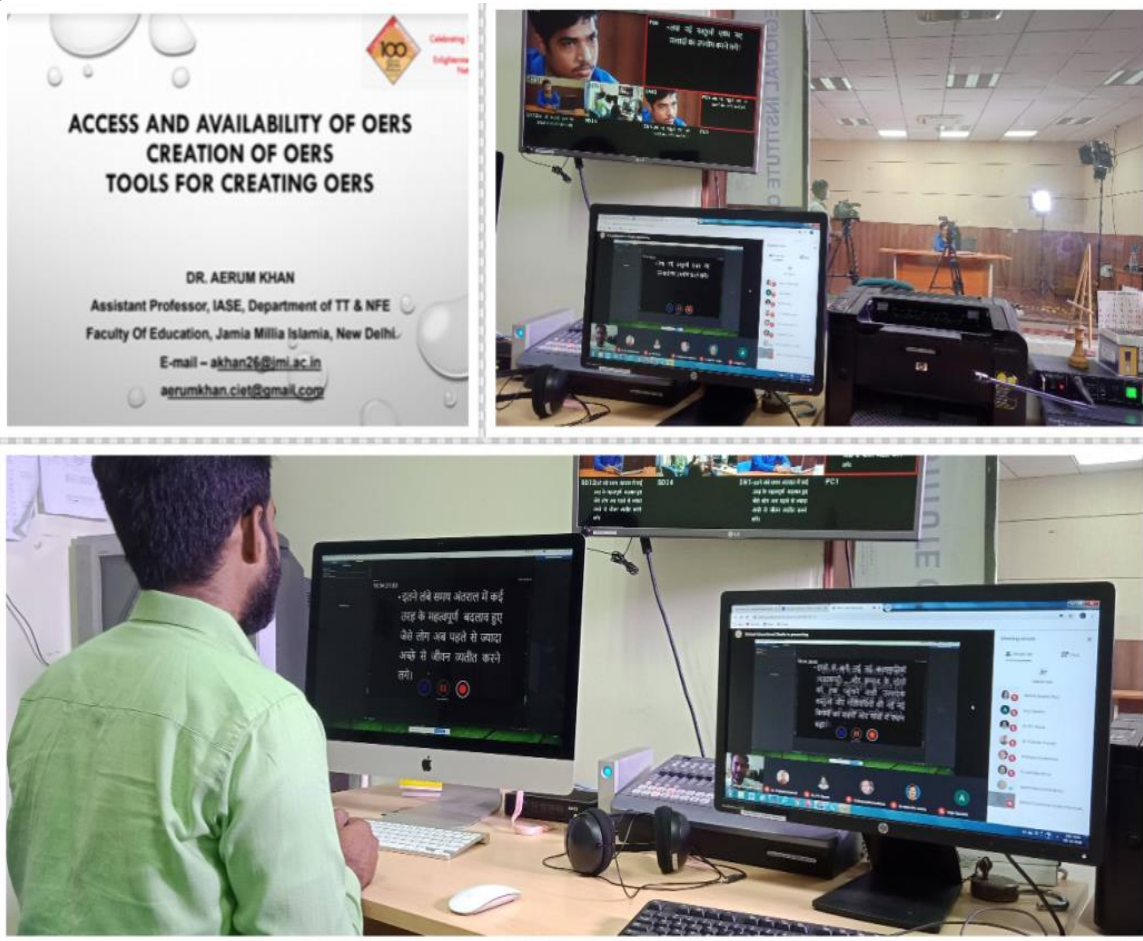
