SHORT Tender NOTICE

The Regional Institute of Education, NCERT, Shyamla Hills, Bhopal – 462002 invites Tender for providing contract in respect of the National Yoga Olympiad, 2023 to be held in the premises of Institute from 18-20 June, 2023 from the eligible experienced firms/ equipment's and Man power for Live Streaming and Photography Services Agency.

INVITATION FOR BIDS:

- 1.1 Regional Institute of Education, Shymala Hills, Bhopal - 462002 invites Tenders from reputed equipment's and Man power for Live Streaming and Photography Contractors having minimum five years experience in the field of outdoor equipment's and Man power for Live Streaming and Photography for large gatherings organized by Govt. Departments, including large gathering of students and with minimum average Annual Turnover of Rs.30 lakhs during the last three years i.e. 2021-21, 2021-22 & 2022-23.
- 1.2 The bidders are required to accept all terms & conditions mentioned in the Tender Document. Principal, RIE, Bhopal reserves the right to reject any or all offers without assigning any reason thereof.
- 1.3 It is the responsibility of the bidders to read all the terms & conditions of the Tender Document before submitting the tender in the Institute. Incomplete Tender Documents or bids are liable to be rejected. Tenders received after the due date and time will not be entertained.
- 1.4 National Yoga Olympiad, 2023 will be held at Regional Institute of Education, Shymla Hills, Bhopal – 462002 campus. equipment's and Man power for Live Streaming and Photography would be prepared in the established within the premises; and meals would be served in Institute premises as per the decision taken by the Authorities. The prospective bidders would be allowed requisite opportunity of inspecting the kitchens and Institute Premises. Preference would be given to bidders having previous experience of working in similar environment.
- 1.5 The terms and conditions as indicated below may be noted carefully and complied with while submitting the tender with reference to this enquiry. The bidders who agree to the stipulated terms and conditions, are requested to quote their rates. Non-adherence to terms and conditions may result in rejection of the tender. The tender shall be submitted strictly in accordance with **Proforma enclosed at Annexure-“A”**.

SCOPE OF CONTRACT:

1. The scope of the contract is as under: -
 - a) Suppler for equipment's and Man power for Live Streaming and Photography as per the list Annexure-A

QUALIFICATION:

1. The bidder should have a minimum of five years' experience of executing similar contracts with government departments.
2. The bidder should have valid GST registration number & Pan Card and copy of both the documents should be uploaded. The bidder shall upload documentary evidence of executing similar contracts with other Govt. Departments and shall also upload an affidavit on Blacklisting of the firm, if any, by any Government Department, in the prescribed format included in the tender document at **Annexure-“B”**.
3. At the time of opening of tenders, the bidder should be prepared to produce one set of samples of articles of bedding offered for hire, on demand from RIE, Bhopal.

TERMS AND CONDITIONS OF CONTRACT:

- 1 In submitting the tenders, the bidders shall ensure compliance with the following terms and conditions:
2. The tenders for supply of beddings as per the scope of the contract given above, should be signed by the authorized person and his full name and status should be indicated below his signature. For this purpose, an

- undertaking from the bidder regarding authorized person may be uploaded. All pages of tenders are to be signed with office seal. Incomplete offers will be considered as unresponsive and will be rejected.
3. Overwriting/cutting/erasing, if any, should clearly be indicated and should be authenticated/attested by the bidder. A certificate to the effect that "No cutting/overwriting in the rates etc. have been made." is required to be furnished along with the quotation of their otherwise bid will be rejected.
 4. All tenders must be accompanied by an Earnest Money Deposit (EMD) for an amount of Rs. 25,000/- (Rupees Twenty Five Thousand Only) in the form of Demand Draft/Bankers Cheque, drawn in favour of Principal, RIE, Bhopal and payable at SBI, RCE Branch, Shyamla Hills, Bhopal. The EMD will be liable to be forfeited if the bidder withdraws or impairs the tender in any respect. No interest will be paid on EMD which will be refunded to the unsuccessful bidders as soon as tenders are opened and successful bidder is declared.
 5. The successful bidder shall not sublet/transfer/re-assign/outsource the contract further.
 6. The right of acceptance of tender (s) will rest with the Principal RIE, Bhopal. Also, RIE, Bhopal is not bound to accept the **lowest tender** and reserves the right to reject any or all the tender(s) received without assigning any reasons.
 7. The rates should be quoted for one set of one mattress, two white bed sheet and one pillow with cover in figures as well as in words and should be inclusive of all taxes/levies. In case if any mismatch in figure and words the lowest rate quoted in either figure OR words will be taken for consideration.
 8. The date/time by which supply of the contracted items in accordance with the scope of contract mentioned in Para 3 above, would be completed, should be clearly mentioned in the tender, failure to comply with the terms and conditions and time-limits set in the tender may result in termination of contract.
 9. The successful bidder shall be required to furnish performance security for an amount of 10% of the total value of the contract, at the time of commencement of supply of stores, in the form of an amount payee demand draft drawn in favour of Principal, RIE, Bhopal payable at SBI, RCE Branch, Shyamla Hills, Bhopal, to ensure due performance of the order/contract in accordance with the terms and conditions set out in the tender document. Further, such performance security should remain valid for a period of 60 days beyond the date of completion of all contractual obligations. No interest will be paid on such deposit.
 10. For the entire duration of the performance contract, the bidder/contractor shall remain available at the postal address furnished in the bid. Any change in the address must be communicated to RIE, Bhopal, well in time.
 11. The Contractor will not lodge any claim with regard to interest for delay due to any administrative reasons, in settlement of his dues.
 12. The Earnest money of the successful bidder will be refunded immediately on receipt of performance security being deposited against the contract. However, the same shall not carry any interest.
 13. No advance payment will be made. Those who do not accept this condition, need not submit their bids. The bids demanding advance payment in full or part are liable to be rejected without any notice.
 14. Full payment will be made against the duly-stamped pre-receipted bill (in triplicate) after completion of the contract.
 15. The tenders in accordance with the terms and conditions set out in this tender notice, may be addressed to Principal, RIE, Shyamla Hills, Bhopal- 462002.
 16. Tender will be received up to 14.00 hrs. on 12/06/2023 at Room No. 3 in the office of Section Officer (Estt.), RIE, Shyamla Hills, Bhopal-462002, after which the tenders will be opened on 12/06/2023 at 15.00hrs. No tenders will be accepted, under any circumstances, after the due date and time prescribed herein for receipt of tenders. RIE, Bhopal will not be responsible for any postal delay. In case the last day of receipt of tenders is declared a holiday on any account, the tenders will be received and opened on the following working day.
