#### **INVITATION FOR BIDS:**

1. RIE, Bhopal is a constituent unit of NCERT, an Autonomous Organization under Ministry of Education and intends to hire 'beddings' for the Kala Utsav 2024-25 event to be organized at its premises. Sealed e-tenders for supply of beddings on hiring basis are invited as per terms and conditions set out in this tender document.
2. The terms and conditions as indicated below may be noted carefully and complied with while submitting the tender with reference to this enquiry. The bidders who agree to the stipulated terms and conditions, are requested to quote their rates. Non-adherence to terms and conditions may result in rejection of the tender.

#### **SCOPE OF CONTRACT:**

3. The scope of the contract is as under:-
  - a) About 950 persons (approx) including school children and their escorts/teachers are expected to assemble and stay at the RIE, Bhopal campus. Bedding is required to be provided for the entire assemblage.
  - b) The actual number of arrivals will be known only by 01/01/2025. Supply of beddings shall be limited to the actual arrivals. The beddings shall be supplied immediately on arrival and assignment of rooms to the participants.

- c) Each bedding set shall comprise one mattress, one white bed sheet, one woolen blanket/quilt (Razai) and one pillow with white pillow cover. The bedding sets shall be thoroughly clean without any dirt, stains or foul smell and shall be germ-free. Unclean, torn, damaged, foul smelling or germ-infested articles shall not be accepted under any circumstances.
- d) The bed sheet and pillow cover shall be changed, and made germ-free, every alternate day, if required by the committee members or users.
- e) An authorized representative of the contractor shall remain present at the camp venue at all times to ensure fault-free service and deal with complaints, if any.

**BIDDERS' QUALIFICATION:**

4. The bidder should have a minimum of three years' experience of executing similar contracts with government departments.
5. The bidder should have a valid GST registration number & Pan Card and a copy of both the documents should be uploaded. The bidder shall upload documentary evidence of executing similar contracts with other Govt. Departments and shall also upload an affidavit non Blacklisting of the firm, if any, by any Government Department, in the prescribed format included in the tender document at **Annexure-"A"**.
6. The bidder should produce one set of samples of articles of bedding offered for hire on 05.12.2024 at 11.30 am RIE Bhopal compulsorily. The Committee will verify the sample materials and the tenders will be based upon acceptance/rejections of samples.
7. The bidder should have a local registered office at **Bhopal (MP)** district and proof of the same should be submitted invariably.

**TERMS AND CONDITIONS OF CONTRACT:**

8. After award of contract the contractor has to deposit 5% of total contract annual value as Performance Security Deposit that shall be payable through online to the A/c payee account number 10026515348, IFSC Code SBIN0002889 payable at State Bank of India, RCE Branch, Bhopal. Performance Security should remain valid for 2 months beyond the date of completion of all contractual obligations.
9. In submitting the tenders, the bidders shall ensure compliance with the following terms and conditions:
  - The tenders for supply of beddings as per the scope of the contract given above, should be signed by the authorized person and his full name and status should be indicated below his signature. For this purpose, an undertaking from the bidder regarding authorized persons may be uploaded. All pages of tenders are to be signed with an office seal. Incomplete offers will be considered as unresponsive and will be rejected.
  - Overwriting/cutting/erasing, if any, should clearly be indicated and should be authenticated /attested by the bidder. A certificate to the effect that "No cutting/overwriting in the rates etc. have been made." is required to be furnished along with the quotation otherwise the bid will be rejected.
  - All tenders must be accompanied by an Earnest Money Deposit (EMD) for an amount of Rs. 10,000/- (Rupees Ten Thousand Only) in the form of Demand Draft/Banker's Cheque, drawn in favour of **Principal, RIE, Bhopal** and payable at, Bhopal. The EMD will be liable to be forfeited if the bidder withdraws and impairs the tender in any respect. No interest will be paid on EMD which will be refunded to the unsuccessful bidders as soon as tenders are opened and successful bidder is declared.
  - The successful bidder shall not sublet/transfer/re-assign/outsource the contract further.
  - The right of acceptance of tender (s) will rest with the Principal RIE, Bhopal. Also, RIE, Bhopal is not bound to accept the **lowest tender** and reserves the right to



reject any or all the tender(s) received without assigning any reasons.

- The rates should be quoted for one set i.e one mattress, one white bed sheet, one woolen blanket/ quilt (razai) and one pillow with cover in figures as well as in words and should be inclusive of all taxes/levies. In case, if any mismatch in figure and words the lowest rate quoted in either figure OR words will be taken for consideration.
- The date/time by which supply of the contracted items in accordance with the scope of contract mentioned in Para 3 above, would be completed, should be clearly mentioned in the tender, failure to comply with the terms and conditions and time-limits set in the tender may result in termination of contract.
- The successful bidder shall be required to furnish performance security for an amount of 03% of the total value of the contract, at the time of commencement of supply of stores, in the form of an amount payee demand draft drawn in favour of General fund Account payable at Bhopal, to ensure due performance of the order/contract in accordance with the terms and conditions set out in the tender document. Further, such performance security should remain valid for a period of 60 days beyond the date of completion of all contractual obligations. No interest will be paid on such deposits.
- For the entire duration of the performance contract, the bidder/contractor shall remain available at the postal address furnished in the bid. Any change in the address must be communicated to RIE, Bhopal, well in time.
- The Contractor will not lodge any claim with regard to interest for delay due to any administrative reasons, in settlement of his dues.

10. The Earnest money of the successful bidder will be refunded immediately on receipt of performance security being deposited against the contract. However, the same shall not carry any interest.

11. No advance payment will be made. Those who do not accept this condition, need not submit their bids. The bids demanding advance payment in full or part are liable to be rejected without any notice/Communication.

12. Full payment will be made through PFMS against the duly-stamped pre-receipted bill (in triplicate) after completion of the contract.

13. The tenders in accordance with the terms and conditions set out in this tender notice, may be addressed to the Principal, Regional Institute of Education, Bhopal-462002.

14. Tenders can be uploaded as per schedule mentioned above. Tenders will be opened as per schedule.

15. Resolution of Disputes

- The RIE, Bhopal and the bidder shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the contract.

- If, after thirty (30) days from the commencement of such informal negotiations, the RIE, Bhopal and the bidder have been unable to resolve amicably a contract dispute, either party may require that the dispute be referred for resolution to the formal mechanism.

- The dispute resolution mechanism to be applied shall be as follows:

- (a) A dispute or difference arising between the RIE, Bhopal and bidder relating to any matter arising out of or connected with the contract, such dispute or difference shall be referred to the International Centre for Ultimate Dispute Resolution by the Principal, RIE. The award of the Arbitrator shall be final and binding on the parties to the contract subject to the provision that the Arbitrator shall give a reasoned award.

- (b) The Indian Conciliation and Arbitration Act, 1996, the rules there under and any statutory modifications or re-enactments thereof, shall apply to the arbitration proceedings.

- (c) If the parties fail to resolve the dispute then the dispute shall be referred to the Principal, RIE, for Arbitration. The Principal may arbitrate himself/herself or in his/her discretion, may

- appoint any other person as an arbitrator to adjudicate upon the dispute. The decision of the arbitrator shall be final and binding on the parties.
- The venue of arbitration shall be RIE, Bhopal.

- **Performance Security Deposit:**

- The successful tenderer will have to deposit a performance security (security deposit) for an amount of 70,000/- (Rupees Seventy Thousand only) for hiring the vehicles during the Kala Utsav 2024-25. The Security Deposit will not be adjusted against any payment due to the firm from the Department or the Central Government.
- The Security Deposit can be forfeited, wholly or partly, by order of the competent authority in the event of any breach or negligence or non-observance of any condition of contract or for unsatisfactory performance or for non-acceptance of the work order. The performance guarantee will be refunded to the

- A letter of intent will be issued to the successful bidder/bidders. Successful bidders shall have to submit a performance security bond within 5(five) days from the issue of the letter of intent, from scheduled bank as per the format given in Annexure-II.
- The final work order will be issued only after the production of the performance security bond. EMD of unsuccessful bidder shall be refunded within a week of the receipt of the performance security bond.
